## Course Description

<b>Course Title</b>	An In-depth Study in Civil Law	<b>Course Number</b>	03017111
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The general curriculum includes the general theory of obligation in terms of its sources, provisions, evidence, and the study of sales, lease, agency, and contracts. It also includes a special and in-depth study of one of the civil law topics such as: the theory of nullity, the theory of civil liability and consequence of perdition.

<b>Course Title</b>	An In-depth Study in Commercial Law	<b>Course Number</b>	03017131
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The general curriculum for studying this course includes the provisions of commercial law in general, such as commercial business, the trader and his obligations, commercial contracts, bankruptcy, commercial papers and bank operations. It also includes a special in-depth study of one of the commercial law topics such as bankruptcy systems, commercial papers or bank operations.

<b>Course Title</b>	An In-depth Study in Criminal Law	<b>Course Number</b>	03027121
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The general curriculum includes the general theory of crime and punishment, penal responsibility, contributing to crime, general provisions of the adversarial criminal procedures, methods of proof and they can be challenged. It also includes a special, in-depth study in one of the criminal law topics, such as: criminal liability and participation in the crime or criminal investigation, or any topic in the criminal procedures law.

<b>Course Title</b>	An In-depth Study in Public International Law	<b>Course Number</b>	03027161
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The general curriculum for studying this course includes the theory of public international law, its sources and persons, international responsibility, peaceful settlement of international, armed conflicts, law of the seas, and international organizations. It also includes a special in-depth study of one of the topics of public

international law, such as: international responsibility, peaceful settlement, and international disputes.

<b>Course Title</b>	An In-depth Study in Administrative Law	<b>Course Number</b>	03027151
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The general curriculum for studying this course includes the definition of administrative law and its relationship with other laws, its application criteria, the definition of centralization, administrative decentralization, public office, public funds, administrative control, and the privileges of public administration. It also includes an in-depth study of one of the administrative law topics such as: public employment, administrative contracts, administrative decisions, and regulations. The curriculum also includes a study of this material general theory of administrative judiciary in terms of its origin and development, the principle of legality, types of control over the work of the public administration and the lawsuit of cancellation in terms of its definition, conditions of acceptance and aspects of cancellation.

<b>Course Title</b>	An In-depth Study in Scientific Research Methods	<b>Course Number</b>	03017101
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

in preparing and writing legal scientific research by introducing scientific research, methods of preparing it, and the steps followed, and identifying the most important mistakes in writing scientific research and introducing the formal and objective aspects of scientific research. This course includes the concept of scientific research and its importance, preparation for writing the research, selecting the topic, the research title, the research plan, the stage of inventorying references and sources, the method for reading references and sources and making use of them, writing the body of the research, the formal aspects of the research, the scientific trust, documenting the research, common mistakes in writing research and how to discuss and defend the research.

## Second: Elective Courses

<b>Course Title</b>	An In-depth Study in Law of Evidence & Procedure	<b>Course Number</b>	03017212
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The course includes a description of the nature and objectives of the Evidence Law, methods of proof in civil and commercial matters, and its rules. Objective and procedural rules, proof doctrines and the position of the Jordanian legislator on these doctrines, an in-depth study related to the development of modern scientific means and their impact on the means of proof, the extent of authenticity of modern devices in proof if litigants use them before the courts, including the outputs of computerized information systems, electronic writing, and electronic signature. As for the law of procedure, this course is concerned with introducing the implementation law and the tasks of the execution departments in Jordan in implementing judicial decisions with an in-depth study of one of the important issues such as implementation obstacles and its mechanisms, the implementation of foreign or Arab court rulings associated with the issuance of judicial decisions from national courts.

<b>Course Title</b>	An In-depth Study in Philosophy of Law	<b>Course Number</b>	03017202
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

This course includes an in-depth study of the philosophy of law by studying the most general topics in the field of law and the most important topics in this science, such as the basis of obligation, the issue of justice, the emergence of law and its objectives, methods of interpretation and application, as well as contemplation, contemplation, analysis, reasoning, investigation, investigation, interpretation, induction, deduction and thinking, considering these matters are the way And the conduct and methodology in criticizing the legal text, which is one of the requirements of the legal profession, as the law without the philosophy of law does not go beyond the study of what is a legal being, while the law with philosophy reaches what should be the legal text. Accordingly, the philosophy of law aims to define the essence of law, its nature, essence and characteristics, the general characteristics of its development and the factors of this development.

<b>Course Title</b>	An In-depth Study in Civil Procedures Law	<b>Course Number</b>	03017213
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The study includes the fundamental nature of the Law of Civil Procedure, the judicial organization, the rules of jurisdiction, the theory of the case, the defenses, the judgments, and the methods of appeals therein. It also includes an in-depth study and a comparison of one of the important topics such as the theory of interest in the lawsuit

as interest is the subject of the case and the international jurisdiction due to the expansion of special legal relations between countries.

<b>Course Title</b>	An In-depth Study in Private International Law	<b>Course Number</b>	03017214
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

This course includes a thorough in-depth study of the definition of the general theory of private international law, its definition, development, topics, general theories of conflict of laws, international jurisdiction, and the implementation of foreign judgments. Referral, impediments to the application of foreign law, and the rules of attribution that the Jordanian legislator came up within civil law, then the course examines the controls of international jurisdiction contained in the Civil Procedure Code, and finally the conditions for implementing a foreign judgment according to the Jordanian Foreign Judgment Execution Law.

<b>Course Title</b>	An In-depth Study in Intellectual Property	<b>Course Number</b>	03017215
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The general curriculum for studying this subject includes the definition of intellectual property rights, their types, conditions, and procedures for registering them, the rights granted to their owners, and the international agreements related to their protection. It also includes an in-depth study of one of its topics and its most important conventions.

<b>Course Title</b>	An In-depth Study in Public Finance and Financial legislations	<b>Course Number</b>	03027252
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The curriculum for studying this subject includes the state's expenditures, revenues, its general budget, Jordanian tax legislation, and state resources in terms of its private property, taxes, fees, and public loans. It also includes an in-depth study of a topic such as: income tax or customs disputes.



<b>Course Title</b>	An In-depth Study in Sharia'a and Islamic Jurisprudence	<b>Course Number</b>	03017216
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The course deals with a topic of private law from the point of view of Islamic law represented by Islamic jurisprudence, for example studying one of the sources of obligation in Islamic jurisprudence, such as a study of the theory of the contract or guarantee (liability), a comparative study of Islamic jurisprudence and statute, or the position of Islamic jurisprudence on the donation and bequest of human organs, or interest ... and so on.

<b>Course Title</b>	An In-depth Study in Social Security Law	<b>Course Number</b>	03017217
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

This course deals with nature of the Social Security Law is and the basic principles on which it is based, the role of the Social Security Institution in providing job, health, social and economic security for the working class and how to reach an equation that guarantees a fair process for the distribution of income. It also explains disability, old age, death or work injuries .. maternity insurance .. and health insurance, as well as how to calculate contributions and retirement rights for the insured, and methods for objecting to decisions issued in this regard.

<b>Course Title</b>	An In-depth Study in Constitutional Law and Political Systems	<b>Course Number</b>	03027241
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The general curriculum includes the nature of constitutional law and political systems and the relationship between them and other laws, as well as the definition of the state, its elements and characteristics, and sovereignty therein, as well as the government and its types, sources of constitutional law, types of constitutions, the principle of the supremacy of constitutions, oversight of the constitutionality of laws, and a thorough study of one of the main topics in it.

<b>Course Title</b>	An In-depth Study in Human Rights	<b>Course Number</b>	03027203
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The general curriculum for the study of this subject includes the definition of human rights, their types, development, and codification in contemporary systems and

constitutions, as stated in international declarations and charters, as well as focusing on one of the human rights issues and their national and international guarantees.

<b>Course Title</b>	An In-depth Study in International Trade	<b>Course Number</b>	03017232
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The general curriculum includes introducing international trade law in national and international concepts and studying international contracts, the most important of which is the international sale contract in all its forms in addition to some model contracts that have been developed in this field, with reference to the relationship of this law with international commercial arbitration.

<b>Course Title</b>	An In-depth Study in Maritime Law	<b>Course Number</b>	03017233
<b>Department</b>	Private Law	<b>Credit Hours</b>	3

The course deals with the legal rules to which the ship and navigation are subject, the legal nature of the ship and the plane, and the identification of the legal provisions for the legal actions that apply to each of them such as selling, mortgaging, renting and seizure, in addition to identifying the privileges rights received on the ship, and the legal provisions of contracts for the exploitation of the ship and aircraft, in particular maritime and air transport, whether in relation to goods or persons, and the study of shipping documents, documents of transporting persons by air, and the provisions of the responsibility of the sea and air carrier in all respects.

<b>Course Title</b>	An in-depth study of the administrative judiciary	<b>Course Number</b>	03027253
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

The curriculum also includes a study of this material general theory of administrative judiciary in terms of its origin and development, the principle of legality, types of control over the work of the public administration and the lawsuit of cancellation in terms of its definition, conditions of acceptance and aspects of cancellation.

<b>Course Title</b>	An in depth Study in Criminal Procedures Law	<b>Course Number</b>	03027222
<b>Department</b>	Public Law	<b>Credit Hours</b>	3

This course includes a definition of the Criminal Procedure Law and the scope of its application. It also includes the steps to file a public right case and what are the restrictions on this legal procedure, also the reasons for dropping it, inference stage and preliminary investigation, the general principles of trial, the distribution of jurisdiction over crimes and the general principles governing public hearings. The course also includes a study of annulment and the procedures of the criminal trial at the Magistrate's Court and at the Court of First Instance and the methods of appealing the judgments and implementing the penal judgments.
