Principles of Commercial Law

(3 Cr.Hrs) Prerequisite (03011102)

The topics included are the merchant, his qualifications, and commercial capacity; the commercial enterprise, its fund, its elements, and protection; the commercial book (obligatory and discretionary) and its proof of power; the commercial register; the commercial contract in general as well as the commercial mortgage, the commission agency, and brokerage.

03021161

Public International Law (1)

(3 Cr.Hrs) Prerequisite (-)

In addition, the theory of the state is explicated as the main person of international law with rights and obligations.

International treaties are emphasized including their conclusion, conditions, effects, invalidation, and abrogation. State recognition is also explained in terms of its nature, forms and retraction. A reference whenever possible is made to the rules of Islamic shari'a relevant to the above topics.

03021141

Political Systems and Constitutional Law

(3 Cr.Hrs) Prerequisite (-)

The course includes: the implications of a constitution, types of constitutions, their origin and end, the relative decline of their value, the maintenance of their supremacy, especially what relates to censorship and its political and legal applications. Moreover, the concepts, the constituting elements, and the types of legal qualification of the state are explained within the political and constitutional framework. Also included are kinds of government and their various constitutional and political foundations. The concepts of a democratic government and its variety of forms are explored. Meanwhile, the position of Islamic shari'a towards constitutional issues is given a special attention.

03021251

Administrative Law (1)

Study Plan to obtain B.A in Law

(3 Cr.Hrs) Prerequisite (03011102)

The descriptive characteristic of this law as related to other branches of law is emphasized. The concept of an organization as a juristic person is explained including its types, liability, and dissolution. Administrative centralization and decentralization are briefly touch upon in terms of definitions, elements, forms, and causes. The legislative, executive and judicial powers of state administration are also explained. Examples of all the above topics are discussed with special reference to what applies to the Hashemite Kingdom of Jordan.

03021121

Criminal Law

(3 Cr.Hrs) Prerequisite (03011102)

Penal law is explicated in terms of concepts, objectives (prevention and deterrence), content, branches, proportion, expiry. On the other hand, crime is studied in terms of definition, classification, and causes. This includes a study of crime components: the legal aspects, the physical elements, the ethical dimensions. The allocations of penal liability are also studied in terms of the principal, the obstructor, the inciter.

03013215

Social Security Law

(3 Cr.Hrs) Prerequisite (-)

This includes: insurance against on-work injuries, occupational diseases, old age, death, and disability; rules of insurance against disability for illness and maternity; comprehensive health insurance; insurance against unemployment; family grants. The rules of the first two types of insurance are analyzed in details as they are applied in Jordan.

03021262

Democracy & Human Rights

(3 Cr.Hrs) Prerequisite (03021161)

This course deals with the historical development of human rights, the international framework, by studying the relevant organizations and conventions. The course includes studying human rights at the national level through the constitution, related legislation, and the national mechanisms available for human rights protection. The course includes studying different forms of governments and democratic systems, and then focuses on international standards for elections and relevant national legislation.

II. Specialization Compulsory Requirements

03012112 **Civil Law – Rules of Obligations**
(3 Cr.Hrs) Prerequisite (03012111)

This includes the identification of the legal means related to executing protection and obligating extenuation as well as the rules governing the association of debtor and association of creditors. The circumstances of obligation dissolution are also explicated, such as acquittal, impossibility of execution, and passage of assigned time.

03012281 **Labor Law**
(3 Cr.Hrs) Prerequisite (03012111)

The course includes studying legal rules governing the individual labor contract, its elements, conclusion, and period with focus on the effects resulting from the obligations of both employer and employee. Termination causes and violation penalty are also included. Moreover, the course deals with legal regulation of collective labor relationships whether relating to collective labor contract, or labor unions, or settling collective labor disputes.

03012213 **Nominated Contracts**
(3 Cr.Hrs) Prerequisite (03012112)

After highlighting the type of terms of obligations adopted in such contracts and the extent of their legality, the course analyses the most outstanding sale and rent types of contracts as relates to the conditions, components, elements, and obligations arranged by each side. Moreover, a detailed study is included concerning the provisions of the law of tenants and landlords.

03014284 **Civil Procedures Law**
(3 Cr.Hrs) Prerequisite (03012111)

This includes the judicial constitution and organization of courts in Jordan, their grades (levels), the judges and their assistants, and the rules of jurisdiction. Then the theory of civil claim is detailed including definition of its legal nature, litigation, and procedures. This is followed by the study of theory of judicial decisions including types of rulings, contesting ruling, and procedures relating to mistrial, retrial, repeal, and appeal.

03013114 **Civil Law (Real Rights)**

(3 Cr.Hrs) Prerequisite (03011211)

The analysis of the first type includes detailing of rules relating to: rights of ownership, means of its protection, restrictions thereupon, kinds of ownership, causes of its acquisition, and rights emanating therefrom (right of disposition, easement, right of user, right of residence, right of usufruct). On the other hand, the analysis of the second type elaborates on the initiation, effect, and dissolution of security and possessive mortgages. The course ends with the clarification of rights of privilege including real estate privilege.

03014164

Private International Law

(3 Cr.Hrs) Prerequisite (03012112)

This includes the study of the general theory underlying the conflict of laws, its principles, domain, rules, and ways of conflict resolution. The case of foreign law application at national courts is analysed in terms of permissibility and rejection. The course also examines the rules governing choice of law and rules of evidence in what relates to personal status, contractual obligation, the enforcement of foreign rulings, and arbitration institutions and resolution.

03013282

Law of Evidence and Procedure

(3 Cr.Hrs) Prerequisite (03014284)

This includes a study of the objective and procedural rules governing the burden of proof and its requirement. Also, a study is conducted on the means of proof in the Jordanian Evidence Act and their procedures including: writing, testimony, oath, witness, admission, material evidence, and expertise. In addition, the study deals with the Enforcement Act and its amendments and the Department of Enforcement as means of judicial protection.

Finally, the study covers means of compulsory execution of the law in what relates to in debtor's property and person.

03012132

Commercial Law – Corporations and Bankruptcy

(3 Cr.Hrs) Prerequisite (03011231)

This includes the study of the following types: general solidarity companies, limited liability companies, foreign companies, incorporated foreign companies, limited general incorporation companies, and mergers. Also, studied are the rules governing registering and trading stocks as well as shareholding and securities. On the other hand, the course deals with bankruptcy: its rules, procedures, and effects; management of assets by a designated committee; simple compromises; reputation restoration; and protective reconciliation.

03014134

Commercial Papers

(3 Cr.Hrs) Prerequisite (03012132)

This includes studying the development of various types of commercial papers, their characteristics, functions, and obligations. This part of the study also deals with the legal rules and implications of issuance, circulations, guarantee, exchange, negotiation, and payment of bonds, stocks, securities, and other bills. Moreover, the course outline the legal provisions regulating the role of commercial banks in the economy and discusses the various banking operations, such as cheques, accounts, credits, deposits, drafts, fund transfer, as well as loans, discounts, and warranties.

03013133

Electronic Commerce

(Cr.Hrs) Prerequisite (03011211)

This course discusses electronic commerce laws in general and in Jordan in particular. It shades the light over strength and weakness points in current Jordanian legislation mainly the Electronic Transaction Code and how this law and other legislation in Jordan can organize e-commerce. It covers as well related international treaties and agreements that deals with international electronic commerce.

03022263

Public International Law (2)

(3 Cr.Hrs) Prerequisite (03021161)

This includes defining a state's territory and territorial elements; a state's international and internal obligations; international persons/bodies conducting international relations; judicial and political settlements of international conflicts and disputes; the law of armed conflicts; and diplomatic and consular relations.

03021242

Jordan's Constitutional System

(3 Cr.Hrs) Prerequisite (302251)

After a brief historical introduction about the Ottoman rule and the Arab Great Revol in 1917, an analysis of the historical development of constitutions in Jordan is followed. The

governmental systems and civil rights and liberties emanating from the 1928, 1947, and 1952 constitutions are comparatively studied. A special reference is made to the maintenance and supremacy of the 1952 constitution and the mechanisms between the governmental branches (the executive, the legislative, and the judiciary) and their functions.

The course concludes with the discussion of the experiences of freezing parliamentary life and the National Consultative Council.

03022252

Administrative Law (2)

(3 Cr.Hrs) Prerequisite (03021251)

The topics include: the definition of administrative authority, the status of a public servant, classification and degrees of public offices, public administration contract, and regulations and procedures of appointment. Also, the study covers the types of assigned services of the civil official and his duties, rights, discipline, and ending of services.

03024155

Administrative judiciary

(3 Cr.Hrs) Prerequisite (03022252)

The study includes: the rise of administrative courts in France; the principles of comprehensibility; supervision over administrative decisions as well as public and judiciary supervision; annulment claim (definition, characteristics, competent court, and admission terms); the extent of application of the aforementioned in Jordan.

03023254

Electronic Administrative Legislation

(3 Cr.Hrs) Prerequisite (03021251)

This module covers issues related to public administration legislation and its modern requirements under current laws and legislation as well as the application of e-administrative in sections such as public occupations and administrative judgments and contracts.

03023153

Public Finance and Tax Legislation

(3 Cr.Hrs) Prerequisite (03021251)

The focus is on legislative applications of these principles on Jordanian finance legislation. The main rubrics include: introduction to finance; new trends in public finance; analyses of direct taxation theory and its financial, social, and reformative development

thereof; objective analysis of key financial legislation in Jordan; Jordanian Budget Law; Jordan's Income Tax legislation.

03022122

Crimes against Persons

(3 Cr.Hrs) Prerequisite (03021121)

The first part deals with types of murder and manslaughter (voluntary and involuntary). This is followed by types of crimes related to physical injury (intentional and unintentional). The final part explicates offences against public order, decency, and personal rights (adultery, rape, abduction, etc.).

03023123

Crimes against Properties

(3 Cr.Hrs) Prerequisite (03021121)

Detailed and in-depth discussions explore widespread examples, such as theft, fraud, breach of confidence. Other related crimes are also analyzed: uncovered cheques, forgery, and bribery.

03024285

Criminal Procedures Law

(3 Cr.Hrs) Prerequisite (03022122)

Introducing the Criminal Procedures Law by introducing the Criminal Procedures and identifying the penal systems, then moving to the procedural legality and the penalty for violating it. It also includes judicial police, their categories, functions, and exceptional powers such as flagrante delicto and assignment. Public right lawsuit is also studied by identifying its parties, which are the Public Prosecution, the defendant, the personal claimant and the person responsible for money, functions and characteristics of the Public Prosecution as well as the restrictions to the public right lawsuit, which is the complaint and the request Permission and claiming a personal right. Proof in the criminal case is also studied, identifying the presumption of innocence and the principle of sentimental conviction, then entering into the methods of proving the criminal case and ending the case by identifying the reasons for the expiration of the criminal case, as well as moving to the civil case resulting from the occurrence of the crime, and getting to know the preliminary investigation conducted By the Public Prosecution and its procedures, such as searches, arrests, interrogations, arrests and disposal of the investigation, then move on to discussing the subject of jurisdiction over the criminal case and the types of this jurisdiction, which are

qualitative, personal and spatial, then move to the stage of trial and identify the principles of litigation, then judgments, their types and conditions, and then move to the methods of appealing judgments, which are the methods Ordinary, which is objection and appeal Negative and unusual methods of appeal, which are cassation, retrial, and cassation by written order

03023224

Information Technology (IT) Crimes

(3 Cr.Hrs) Prerequisite (03023123)

know well the basic concepts in the crimes of information systems and computer networks, as well as to understand the precautionary methods in the process of data exchange and its relationship with national laws and to identify information technology crimes and traditional crime and its development and relationship with technology and the Internet, the characteristics of this crime and types of crimes, including fraud, credit abuse, destruction, theft, crimes of assault on computer programs, crimes of communication technology, assault on private life, slander and contempt, the conditions of these crimes and their material and moral elements, methods of proof, investigation, and seizure, in addition to national and international legislation dealing with crimes.

03024283

Graduation Project

(3 Cr.Hrs) Prerequisite (-)

This includes defining a topic of interest, outlining the main ideas of concern, consulting law references, analyzing collected data, abstracting the results, and organization of findings in a research paper.

III. Specialization Elective Courses

03021256

Media Law

(3 Cr.Hrs) Prerequisite (03021251)

This course includes the definition of the impact of legislation and the ethics on journalism on the work of journalists in terms of practicing their role in accordance with theories of freedom and freedom of opinion and expression in accordance with international

conventions and national legislation.

It includes the definition of the legal and judicial system in Jordan, relevant legislation governing the work of the media and the press, the ethics of journalism, and the legal and regulatory restrictions on practicing this profession in Jordan compared to the best international practices.

Researching the laws related to access to information.

How to exercise the right to criticism and the conditions for exercising it.

The criminal, civil and disciplinary liability of a journalist in case of violating the provisions of laws.

03011104

History Of Law

(3 Cr.Hrs) Prerequisite (-)

The study includes: pre-historical forms of regulating life; the divine provisions in Ancient Egypt, Greece, the Celts and India; laws of Western groups (Dracon Law, Solon Law, and the 12-Plate Law); and laws of Eastern groups (Hamourabi, Mano, Bochorius). A special attention is given to the development of Roman Law and the basic rules pertaining to persons, wealth, rights, and obligations. Also explicated is the history of Islamic Law from the rise of Islam until the Abbasid period.

Finally, the sources of modern legal systems are studied including Latin, Anglo-Saxon, and Germanic bylaws.

03013174

Family Law for Non-Moslems

(3 Cr.Hrs) Prerequisite (302101)

This includes: the concept of marriage and its historical development; pre-marriage procedures; marriage contract, conclusion, and obligations; marriage by power of attorney; marriage inhibitions and barriers; abandonment, separation, divorce, annulment; alimony and guardianship; causes of divorces and consequences.

03013116

Insurance Contracts

(3 Cr.Hrs) Prerequisite (03012132)

This includes: the rise and development of insurance contracts in foreign and Arab countries; types of insurance and the characteristics of each type; the views of Islamic jurists in insurance contracts; the definition of risk and its terms; the rules governing payments; the element of interest in personal property insurances; the technical and legal aspects of constructing and signing of an insurance policy; the obligations of the insured

03023125

Protection Environment Law
(3 Cr.Hrs) Prerequisite (03021121)

General Curriculum: The definition of the Environmental Protection Law includes the elements of the environment that are protected by the law: the wild environment, the water environment and the air environment, the public bodies that supervise the protection of the environment and the role of non-governmental agencies in this field, administrative and criminal protection of the environment, and control authorities working in the field of environmental protection.

Special Curriculum: It includes an in-depth study of one or more subjects of the Environmental Protection Law, such as: the protection of the marine, land and air environment from pollution, legislation to protect environmental diversity and pollution by nuclear radiation. This course also focuses on an in-depth study of the relationship between national law and international law to reinforce the principle of international cooperation to protect the environment.

Crimes against state security
(3 Cr.Hrs) Prerequisite (03021121)

Defining crimes against state security and defining crimes against state security by defining crimes that occur against state security, explaining the general provisions for these crimes, starting the crime of conspiracy, and explaining its conditions, as well as addressing the meaning and conditions of assault in state security crimes and then reporting state security crimes. the course also includes incitement to state security crimes, as well as identifying the jurisdiction to look into state security crimes, then identifying the crimes of the external state security, which is carrying weapons in the ranks of the enemy and invading the intrigues of a foreign country in order to incite aggression against Jordan, then physical sabotage with the intention of paralyzing the national defense and trying to cut off a part From Jordanian lands, to annex it to another country, as well as harboring spies, facilitating the escape of prisoners of war and detainees, then researching crimes related to international law, as well as crimes of espionage, crimes of contacting the enemy for unlawful purposes, crimes of undermining the prestige of the state, national sentiment, and the crimes of contractors, then moving to discuss crimes of internal state security, which are They include the felonies committed on the constitution and the crime of rape of a political or civil authority or military leadership and authorship Armed factions, as well as crimes of sedition, terrorism and terrorist organizations, then crimes that undermine national unity or disturb the nation, and finally crimes that undermine the state's financial standing.

Rules of Islamic Jurisprudence
(3 Cr.Hrs) Prerequisite (03012172)

The teaching of the course aims to enlighten students about the methods of deducing rulings from the legal texts, whether the texts are general or private, absolute or restricted, clear, vague, imperative, or final, and whether they are indicative of the ruling by its expression, by its indication, by its connotation, by its requirements, by its spoken, or in its concept, and by ijthad, its place, its conditions and its ruling, tradition and fabrication and fatwas.

03022265

International Organizations
(3 Cr.Hrs) Prerequisite (03022263)

This includes studying the concept of international organization; the legal entity and applicable laws of organizations; and membership, financing, and jurisdiction. The focus turns to a study of the United Nations, its structure, branches, and agencies. Other regional organizations are studied: the Arab league, the African Unity Organization, the American Countries Organization. The emphasis is on the legal aspects of these organizations.

03023166

Diplomatic Law
(3 Cr.Hrs) Prerequisite (03022263)

First, the law of diplomatic exchange is analyzed in terms of sources, types of delegations, size and ranks of diplomatic corp, tasks of delegates, immunity and privileges, the framework of the Vienna Convention of 1961. Second, consular representation is explored in terms of origin, rules governing consular relations, structure of missions, types of missions, their tasks and immunities, the implications of the Vienna Convention of 1963. The issues of protecting the dispatching state's interest is also explored. Other types of diplomatic missions are also dealt with: missions for international organizations and honorary consuls.

03022268 **Law of the Sea**
(3 Cr.Hrs) Prerequisite (03022263)

03022267 **International Humanitarian Law**
(3 Cr.Hrs) Prerequisite (03022263)

For this purpose, the Hague and Geneva Conventions related to international and non-international conflicts are analyzed. The ways and means of wars are illustrated in terms of weapons and ethics. The scope and nature of protection and treatment of people (civilians, prisoners, the injured, the medical staff) are also analyzed. A degree of importance is given to the enforcement and suppression of gross infringements upon this law.

After a concise introduction of the historical development of sea laws until the United Nations' agreement of 1982, the course deals with various topics: inner water as different from regional water and the legal provisions related to them; boundaries and security jurisdiction of close and semi-closed seas; international rules governing high seas and oceans; laws of sea pollution.

03022257 **Local Governance in Jordan**
(3 Cr.Hrs) Prerequisite (03021251)

The main outlines processes of both systems of governance are explored. The philosophy and basis of local administration are clarified with examples (administrative units with independent finance and regulations; elected local councils running their local facilities; work under the control of central authority). The effects of international conventions and modern trends on local administration are also explored. The central application is the comparison between Jordan's local administration system and other regional and international systems

03023127

Economic Crime

(3 Cr.Hrs) Prerequisite (03023123)

First, the economic crime in Jordan's laws is compared to other political systems in terms of legal principles and domain of application. This is followed by a study of the elements and penalties related to such a crime. Then the course focuses on analyzing examples of such crimes, namely, tariff violation, smuggling, and tax evasion.

03023128

Criminology and Penology

(3 Cr.Hrs) Prerequisite (03021121)

This includes a study of criminal behavior and the factors motivating criminal action. The personal factors are studied: genetic effects, age, illness, and physical build. The social factors are analyzed: the family, school, work, the media, and others. Modern theories of penology are explicated with focus on the concept of correction and behavior modification.

Finally, Jordanian laws on crime and punishment and their execution are compared to other laws and other countries' laws.

03024129

Forensic Medicine

(3 Cr.Hrs) Prerequisite (03022122)

Students are introduced to the importance of medical reports, inspection of dead bodies, autopsy reports, and methods of determining reasons of death, and how these have become essential for establishing facts and evidence that facilitate litigation.

03012158

Tax Income Law

(3 Cr.Hrs) Prerequisite (03023153)

This course aims to introduce the student to the essence of the income tax law in terms of

persons in charge of tax, taxable funds and exemptions of all political, economic, social and personal types, as well as the productive consequences that may be deducted from income and may not be deducted from income, as well as familiarizing the student with how to estimate the tax, especially with regard to the tax return and its submission dates The administrative assessment and the previous initial assessment, and then addressed after that the tax rates and its proportions, appeals against assessment decisions and penalties for violating the provisions of the tax, and in the end, with the aim of linking the theoretical aspect with the practical side, so that the course includes a set of tax applications

03012288 **Arbitration Law**
(3 Cr.Hrs) Prerequisite (03014284)

The Jordanian Arbitration Law is discussed in comparison with other regional and international arbitration laws. Judiciary supervision over arbitration's procedures, limits, and effects is also pointed out. Then the course focuses on formal and objective conditions of arbitration and on means of proof in the arbitrator's decision. Terms and means of implementation of the decision are also discussed.

03022159 **Administrative contracts**
(3 Cr.Hrs) Prerequisite (03021251)

The course deals with the nature and types of administrative contracts, the legal system for concluding them and the implications for the administration and for contracting with the administration, as well as the methods of terminating administrative contracts and disputes related to them, as well as the legal system for electronic administrative contracts.

03021289 **Methods of Legal Scientific Research**
(3 Cr.Hrs) Prerequisite (-)

Teaching the methods used in preparing and writing scientific research by introducing scientific research, methods of preparing it and the steps followed in that, and identifying the most important errors in writing scientific research, and introducing the formal and objective aspects of scientific research.

03012237 **Industrial and Commercial Property**
(3 Cr.Hrs) Prerequisite (03011211)

Industrial property protection is studied on the international level, i.e, the Paris Convention, its amendments, and consequences thereof on developing countries and technology transfer. This is followed by a study of local legislations on patents, designs, and utility models. Then the law on trademarks and goods' marks is analyzed in terms of requirements, issuance, registration, termination, and protection. Commercial titles, addresses, and rights are also covered in depth. Rules related to technology transfer, improvement, and know-how are explained. Finally, the course focuses on literary property in the copyright law with reference to the Bern Convention on the international protection of copyrights.

IV. Supportive Requirements

03011171

Introduction to Islamic Jurisprudence
(3 Cr.Hrs) Prerequisite (-)

The course outlines the meaning and principles of Islamic legislation; the terms of religion, shar', shari'a, and tashree'; the meaning of ijtihaad; the difference between shari'a, sect, and religion; fields of fiqh as differentiated from fundamentals of fiqh; a general view of concepts, such as ownership, contract, abrogation, corruption, capacitation, guardianship, and custom.

03012172

Personal Status Jurisprudence (1)
(3 Cr.Hrs) Prerequisite (03011171)

1. Engagement and its provisions.
2. Marriage rules: legality, principles, conditions, the marriage contract, spouse obligations, forbidden marriages, the wife's rights.
3. Birth rules: lineage, custody, feeding.
4. Divorce rules: implications, conditions, types (khul', ila', raj'a, zihar), separation, effects, udda, alimony.

03012273

Personal Status Jurisprudence (2)

(3 Cr.Hrs) Prerequisite (03012172)

This course aims at dealing with legal matters related to the effects of a person's death on his property and wealth.

Rules related to wills: structure, provisions, the will maker, the heirs, the minors, compulsory will, abrogation of will, types of wills.

2. Rules of inheritance: reasons, legality, prohibitions, kinship eligibility.

Rules of Waqf: meaning, legality, real estate and other types, effects, administration.

03012103

Legal Terminology in English

(3 Cr.Hrs) Prerequisite (-1)

Knowledge of English/French legal terms equivalent to Arabic by studying commitment theory, rights theory and different branches of law. Students are trained to read foreign legal books.

03014286

Fundamentals of Legal Drafting and Judicial Applications

(3 Cr.Hrs) Prerequisite (03014284)

A variety of cases and law suits are chosen to enable students to observe the way suits are initiated, conducted, and proceed until a final judgment is rendered in courts of various degrees.

03021201

Human Rights

(3 Cr.Hrs) Prerequisite (-)

First, the study brings into focus the development of international and regional instruments and systems for the protection of human rights, namely, the United Nations' Declaration of Human Rights and the numerous conventions, agreements, organizations, mandates, and norms. Then the study analyzes the development of types and ranges of human rights: the first generation of right to life and equality; the second generation of right to work; and the third generation of rights of women, children, and the environment. Most importantly, the study presents the ways of protecting humans and their rights: the legal methods, such as reports, complaints, and investigations of committees; political and economic pressures; intervention by force (the theory of intervention for the sake of humanity). Muslim, Arab, and local views and systems of concern are examined.

03011101

Law in our Life
(3 Cr.Hrs) Prerequisite (-)

The course includes five topics, and they are:

- The first topic, the nature of the law in terms of its meaning and function and the characteristics of the legal rule and how to distinguish legal rules from similar rules.
- The second topic, the divisions of law and its branches and the other divisions of legal rules, and the sources of law.
- The third topic, the judicial system in Jordan in terms of its principles, types of lawsuits, court formations, types and jurisdictions.
- The fourth topic, practical applications of the most important contracts named in the Jordanian civil law, namely the sale and lease contracts
- The fifth topic, the most important Jordanian laws and bylaws related to practical life, law of owners and tenants, personal status law, labor law and civil service bylaw, social security law, and Bar Association legislation.
